2.1. Online application

3. School tuition fee

3.1. The annual school tuition and meal fee are to be paid in 12 instalments, which has been approved by the Education Bureau. The monthly tuition and meal fee for 2024/25 is HK\$2,130.

5. Application for the "2025/26 Registration Certificate for Kindergarten Admission"

- 5.1. Education Bureau (EDB) implement the Kindergarten Education Scheme, EDB will use the "Registration Certificate for Kindergarten Admission" as the document for registration in the 2025/26 school year.
- 5.2. Parents are required to submit an application for the "2025/26 Registration Certificate for Kindergarten Admission" (hereafter referred as "2025/26 RC") to EDB from September to November 2024. The "RC" would be open for applications in September 2024. EDB would announce and upload the details of application onto EDB's website (https://www.edb.gov.hk/kl-admission_e) in due course.

6. Admission Criteria

- 6.1 The applicant with family need will be considered in higher priority when applying for the long whole day classes.
- 6.2 The applicant with sibling currently studying in the Nursery School will be considered in higher priority.
- 6.3 Families with social needs either referred by Social Welfare Department or registered social worker.
- 6.4 Children who are presently studying in Tung Wah Group of Hospitals Nursery Schools or day creche.
 - (As the number of school places is limited, please be aware that not all applicants fulfilling the criteria will be guaranteed a school place.)

7. Interview Arrangement

- 7.1 The Nursery School will arrange interview for all applicants
- 7.2 Interviews will be conducted on November 2024. Parents would be informed by call.
- 7.3 Individual or/and group interviews will be arranged
- 7.4 Parents should accompany their child for the interview

8. Non-Chinese Speaking Children

- 8.1 For Non-Chinese Speaking family, parents can contact us if interpretation / translation service if required, and we allow parents and children to be accompanied by a Chinese speaking relative/friend during the interview to facilitate communication

9. Announcement of Admission Results

9.1 We will inform parents of the K1 admission results before 13 December 2024 by call.

10. Registration Arrangement

10.1 Successful applicants:

Parents should complete the registration procedures for their child from 2 to 4 January 2025 ("Centralised Registration Dates") by submitting the original "2025/26 RC" to the kindergarten and paying the registration fee.

10.2 Applicants on the waiting list:

Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the original of the "2025/26 RC" to the kindergarten and pay the registration fee. Parents would be informed by call.

- 10.3 Please be reminded that if parents cannot submit the "2025/26 RC" during registration, the kindergarten may not be able to complete the registration process for their child. Hence, parents are required to submit application for the Registration Certificate to EDB within the specified period.
- 10.4 The registration fee for 2025/26 K1 place is HK\$1570. Once the child is officially enrolled, the school will either refund the remaining balance after deducting the first month's tuition fee or request the parents to pay for any outstanding tuition fees within the first month of enrollment.
- 10.5 Should parents decide to change school after registration, please notify the Nursery School in writing. The Nursery School will return the "2025/26 RC" but the registration fee will not be refunded. Upon returning the "2025/26 RC", the Nursery School will no longer keep the school place for the child.
